### IPM statement

It is the goal of LA Promise Charter High School to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Elimination of significant threats caused by pests to the health and safety of students, staff and the public. Prevention of loss or damage to structures or property by pests. Protection of environmental quality inside and outside buildings.

### IPM team

In addition to the IPM Coordinator, other individuals who are involved in purchasing, making IPM decisions, applying pesticides, and complying with the Healthy Schools Act requirements, include:

### Pest management contracting

- Pest management services are contracted to a licensed pest control business.

### Pest identification, monitoring and inspection

Pest Identification is done by: Community Pest Control

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

Sticky traps are placed in the kitchen, staff lounge, staff restroom and classrooms and checked weekly by School Business Operations Manager and Custodian.  
Repeater mouse traps are placed in the kitchen, staff lounge, staff restroom and classrooms and checked weekly by School Business Operations Manager and Custodian.

**Chemical pest management practices**

If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

This child care center expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses.):

When it is determined that a pesticide must be used in order to meet pest management objectives, the least-hazardous material, adequate for the job, will be chosen. All pesticide storage, transportation, and application will be conducted in accordance with the requirement of the Federal Insecticide, Fungicide, and Rodenticide Act (7 United States Code 136 et seq.), Environmental Protection Agency regulations in 40 CFR, Occupational Safety and Health Administration regulations, St. Anne's policies and procedures, and local ordinances.

**Submittal of pesticide use reports**

- Reports of all pesticides applied by school staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

<sup>1</sup> These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
